CONDITIONS OF PARTICIPATION AND ENTRY Valid 30 May 2022 to 19 June 2022



- 1. Below are the Conditions of Participation and Entry for the NEFF #VirtualRecipeChallenge (**Promotion**) including eligibility, age limits, exclusions and the details of how to enter the Promotion.
- **2.** Information on how to enter and the Prizes form part of these Conditions. Participation in this Promotion constitutes acceptance of these Conditions.
- **3.** The Promoter means BSH Home Appliances Ltd (NZBN 9429035347989) of Level 3, Air New Zealand Building, Smales Farm, 74 Taharoto Rd, Takapuna, Auckland, 0622, telephone 09 477 3522 (**Promoter**).
- **4. Eligibility**: Entry is only open to New Zealand residents with a residential address in New Zealand, aged 18 years or over (**Eligible Entrant**). Employees (and their immediate families) of the Promoter and agencies associated with this Promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or, first cousin.
- 5. Promotional Period means the period commencing 30 May 2022 until 19 June 2022 inclusive.
- 6. Entry: To enter, Eligible Entrants must, during the Promotional Period:
 - a) register for the Promotion at the following link: https://www.neff.co.nz/promotions/masterchef between 30 May 2022 and 15 June 2022 inclusive;
 - b) using the NEFF Virtual Recipe Challenge email sent to Eligible Entrants at approximately 7:30 pm on 17 June 2022 (Email), create a recipe using a minimum of two of the ten ingredients listed in the Email; and
 - c) submit their recipe(s) (including recipe name, ingredients and method) and any other required details by 7:30 pm on 19 June 2022 by clicking the "submission" button in the Email and following the prompts.
- 7. A maximum of three entries are permitted per Eligible Entrant, subject to the following:
 - a) each entry must be submitted separately and in accordance with these Conditions; and
 - b) only one entry per Eligible Entrant will be eligible to receive a Prize Pack.
- 8. Prize means either:
 - a) Major Prize; and / or
 - b) Prize Pack (see condition 14 for more information).
- **9. Nature of the Promotion**: One Eligible Entrant will be selected by a judging panel as the Major Prize winner, having regard to the skill, creativity and originality of their recipe(s) at the Promoter's premises between 20 June 2022 and 22 June 2022.
- 10. The judging panel of the Major Prize will consist of Tim Read and representatives from the Promoter.
- **11.** The Promoter reserves the right to alter the make-up of the judging panel if a judge becomes unavailable at any time.
- 12. Ten randomly drawn Eligible Entrants will receive a Prize Pack.
- **13.** Winners will be notified by 24 June 2022 via telephone and / or e-mail using the contact details provided to the Promoter at the time of entry into the Promotion. The winner's names will be published on the Promoter's website www.neff.co.nz/ promotions/masterchef, NEFF Facebook page (New Zealand) and NEFF Electronic Direct Marketing on 27 June 2022.

14. Prizes:

- a) Major Prize: one Eligible Entrant will win a cooking MasterClass, hosted by professional Chef and former MasterChef winner Tim Read.
 - i. The MasterClass will be hosted at UnserHaus in Auckland, New Zealand on 9 July 2022 at 4:00 pm.
 - ii. The Major Prize winner will be invited to bring one guest to the MasterClass.
 - iii. If the Major Prize winner resides outside of Auckland, the winner and their guest (if applicable) will be provided two domestic return economy airfares up to the value of \$1,000.00, one nights' accommodation and breakfast in a 4-star hotel

(twin-share) and four hotel / airport transfers up to the value of \$100.00 per transfer.

- iv. If the Major Prize winner resides in Auckland, the winner and their guest (if applicable) will be provided one nights' accommodation and breakfast in a 4-star hotel (twin-share) and four hotel / home transfers up to the value of \$100.00 per transfer.
- v. Any other elements e.g. spending money, meals, additional transport, transfers / taxis and all other ancillary costs incurred as a result of taking the Major Prize, unless specified as included, are not included and remain the responsibility of the winner;
- **b) Prize Pack**: 10 randomly drawn Eligible Entrants will win one Prize Pack consisting of one NEFF baking stone, one NEFF tea towel and one NEFF Rimu Spatula.
 - i. Each Prize Pack is valued at \$439.00.
 - ii. Winners will receive the Prize Pack by mail.
 - iii. Winners must allow up to 28 business days from the date they provide their full delivery details to receive the Prize Pack.
- **15.** The Promoter will use reasonable efforts to deliver the Prize or any portion of the Prize within the specified time frames. However, the Promoter is not responsible for delays, which are caused by events beyond the control of the Promoter.
- **16.** If any Prize (or part of any Prize) is unavailable, for whatever reason, the Promoter, in its discretion, reserves the right to substitute the Prize (or that part of the Prize) for a Prize to the equal value and / or specification, subject to any written directions from a regulatory authority. It is a condition of accepting the Prize that winners must comply with all the conditions of use of the Prize and the Promoter's requirements. Each Prize must be taken as stated and no compensation will be payable if a winner is unable to use the Prize as stated.

 - a) to disqualify any Eligible Entrant; or

- e) any tax liability incurred by a winner or Eligible Entrant; or
